A. Approval of August meeting minutes – via Email.

## B. Old Business

1. Fashion Show– This coming Tuesday, September 12<sup>t</sup>, 11:30- 2 PM. Jackie, event coordinator reported. Models and logistics are set. The current head count for the event is 107. Modeling will start at approximately 12:45 PM. Significant door prizes have been assembled. Jackie will greet members and Billie will serve as moderator.

3. Upcoming SEC Event Flyers. Holly provided a copy of the flyer which will be enclosed with checks and updated each month. Resounding approval from SEC members.
4. Death by Chocolate. This event has been tabled until 2015.
5. Children's Halloween Party. Currently scheduled for Saturday, October 25<sup>th</sup>. Holly indicated there are only 3 children signed up, but that number should grow as the calendar turns to October. We will follow the progress. Mishael will be including the information in her flyer.
6. Blues and Bar-B-Que is on for Saturday, November 1<sup>st</sup>, from 6-10 PM. Greg is handling the contacts and details.
7. 2015 Calendar. (Attached with Agenda). After some discussion it was agreed the Fashion Show should be included in next years' events calendar. Holly will add it on Thursday, September 24<sup>th</sup>. This day will work out well as it falls on the first day of Men's Member/Guest, which means Ladies Day on the course is Wednesday on that week only.  
There was also some discussion about reprising an event held a few years ago, which was very well received and attended – Chef Demo Day. This will be pursued with Greg when he returns from vacation.
8. Old Business. The Chili Cook-off de-brief was reviewed. In short, the event was very successful and well attended. The major changes and considerations for next

year are: re-calendaring the event for the Fall (it will take place on Saturday, October 3<sup>rd</sup>), working on an improved (lighter) menu and finding some enticements and greater incentives for participation in the contest.
